Fund Spotlight THIRST LIVING WATERS & ALISON JO JENKINS SCHOLARSHIP FUNDS

Rick and Barb Jenkins crossed paths with the Community Foundation in a time of great personal tragedy. In May of 2007 their beautiful, intelligent and compassionate daughter Alison took her own life. Through their despair, Rick and Barb decided that Alison's memory would best be served by starting a scholarship fund in her memory, thus the Alison Jo Jenkins Scholarship Fund was born. The fund affords EMS professionals the opportunity to further their education to become paramedics. They hope to support community members with the same passion for helping and caring for others as Alison did.

Two years later, Rick, Barb and their son Josh and daughter-in-law Kristy started the THIRST Living Waters Fund to raise the awareness of suicide, promote suicide prevention and support those who have lost loved ones to suicide. They now educate our community about suicide and the stigma of mental illness. THIRST offers a proactive prevention plan through encouraging people physically, emotionally, and spiritually. The THIRST website offers an online chat room, prayer





line and other educational and support services. Funds for THIRST are raised through bequests, gifts and fundraisers.


